FALSE ALARM BY-LAW

THE TOWN OF BARRE HAS ADOPTED A FALSE ALARM BY-LAW, THE PURPOSE OF WHICH IS TO REDUCE THE NUMBER OF FALSE ALARM DISPATCH REQUESTS.

ALARMS REGULATED BY THIS BY-LAW SHALL INCLUDE THOSE INSTALLED WITHIN A HOME OR BUSINESS, THAT PRODUCE AN AUDIBLE SIGNAL ON THE EXTERIOR OR ARE MONITORED BY AN ALARM COMPANY, FOR THE PURPOSE OF REPORTING A BURGLARY, FIRE, OR HOLD UP.

ALARM SITES MUST REGISTER WITH THE BARRE POLICE DEPARTMENT AND PAY A ONE-TIME \$25.00 REGISTRATION FEE. A COMPLETED APPLICATION FORM ALONG WITH REGISTRATION FEE SHALL BE FORWARDED BY MAIL TO THE BARRE POLICE DEPARTMENT AT 40 WEST STREET BOX 902; BARRE, MA 01005.

THE REGISTRATION PROCESS SHALL COMMENCE IMMEDIATELY, HOWEVER, ALARM SITES SHALL NOT BE SUBJECT TO A FINE FOR A FALSE ALARM DISPATCH UNTIL JULY 1ST, 2009.

ANY PERSON OPERATING AN ALARM SYSTEM WITHOUT A PERMIT SHALL BE SUBJECT TO AN ADDITIONAL FINE OF \$100.00 FOR EACH FALSE ALARM DISPATCH.

AN ALARM CAUSED BY A CRIMINAL OFFENSE, FIRE, OR SOLELY FROM A POWER OUTAGE OR EXTREME WEATHER CONDITION, SHALL NOT BE COUNTED AS A FALSE ALARM.

THE USE OF AUTOMATIC DIALERS IS PROHIBITED.

THE TOWN SHALL NOT SERVE AS AN ALARM MONITORING COMPANY.

THE TABULATION OF FALSE ALARMS SHALL COMMENCE ANEW EACH JULY.
